- SPDC's crumbling healthcare system unable to respond to outbreaks of bird flu, extensively drugresistant TB, malaria, dengue and diarrhea. Diseases spread cross Burma's borders.
- Daw Aung San Suu Kyi turns 62 on 19 June, marking her 4,253<sup>rd</sup> day of detention. Birthday celebrations are held throughout Burma and the world.
- Junta-backed thugs continue to harass NLD members. SPDC detains at least 17 political activists.
- SPDC announces National Convention will reconvene on 18 July. NLD will boycott the session. Several ethnic groups also reject the illegitimate and oppressive constitution-drafting process.
- ICRC, ILO, and UN slam the SPDC over continued abuses against civilians, widespread use of forced labor, and restrictions on humanitarian aid.
- India blames SPDC for the increased instability along the border but continues shipping arms to the junta in hopes of getting gas in return.
- Thailand turns away almost 300 refugees, including sick children and women fleeing conflicts in Eastern Burma. In Malaysia, RELA arrest 217 asylum-seekers and UNHCR-recognized refugees from Burma.
- 25,000 people face starvation because of the offensive in Eastern Burma raging since Nov 2005.

#### **KEY STORY**

Health crisis: SPDC killing by neglect

Deadly outbreaks of treatable illnesses underscored the SPDC's impoverishment and obstruction of healthcare, and added greater urgency to a new report on the subject.<sup>1</sup>. IDPs in conflict areas crossed the border to Thailand to seek treatment. The refugee exodus from Burma continues to expose the Thai population along the border to the spreading diseases.

• "Extensively drug-resistant" tuberculosis (XDR-TB): On 11 June, Medecins Sans Frontieres (MSF) in Mae Sot, Thailand, confirmed two cases of XDR-TB among one refugee and one migrant

worker from Burma, both of whom are now missing.<sup>2</sup> There are two other suspected cases. TB in patients from Burma is mutating into drug resistant strains. It is likely that more people are unknowingly carrying and spreading the XDR strain.<sup>3</sup>

- Malaria: In June, the Mae Tao Clinic in Mae Sot witnessed a significant increase in the number of
  malaria patients among refugees and migrants from Burma. According to a senior medic, over 50
  malaria patients were arriving at the clinic every day. Half of the cases were so serious they had to
  be hospitalized.<sup>4</sup>
- **Dengue fever:** On 21 June, 10 children died from hemorrhagic dengue fever in Bassein Township, Irrawaddy Division. Villagers complained that the SPDC has failed to address the growing health crisis. Dengue fever cases also increased significantly in Rangoon. 6
- **Diarrhea:** In the first week of June, three people, including two 3-year-old children, died of diarrhea in Pasin village, Matupi Township, Chin State. The Community-based Health Care Program (CBHCP) reports that they have been blocked by SDPC authorities from entering the village and providing treatment. Two other people died in La Oo, Thantlang Township and three in Cakhang village near the Mizoram border, because of their inability to access proper medical treatment.<sup>7</sup>

# Bird flu again

In June, bird flu was reported on three farms in Pegu and Rangoon Divisions. The SPDC failed to inform poultry farmers for 10 days.

- **3 June:** 28 chickens died on a farm in Pegu Division, marking the first time the disease had been found in the area.<sup>8</sup>
- 13 June: News of the outbreak first appeared in the international press, with the Livestock Breeding and Veterinary Department (LBVD) reporting that about 1,000 birds from the farm had been killed as a precaution.<sup>9</sup>
- **15 June:** The LBVD conceded the outbreak was more widespread. Four new cases were identified on farms in three townships in Rangoon and Pegu Divisions, and nearly 2,000 chickens were culled.<sup>10</sup>

The Food and Agricultural Organization (FAO) continues to assist the LBVD by providing technical assistance in testing and sanitizing affected areas. However, laboratory infrastructure in Burma is so inadequate and antiquated that bird flu cannot be tested outside of urban areas. The SPDC is making matters worse by failing to provide poultry farmers with compensation for their culled chickens. <sup>12</sup>

# Daw Suu: 62 years and 4,253 days

19 June marked the 62<sup>nd</sup> birthday of Burma's pro-democracy leader Daw Aung San Suu Kyi, and 4,253 days in detention. <sup>13</sup> Celebrations for her birthday were held in various locations across Burma:

- In Rangoon, around 300 supporters gathered at the NLD headquarters. Party members and activists released doves and balloons and prayed for Daw Suu's release. <sup>14</sup>
- In Kyuakpadaung Township, Magwe Division, over 200 NLD members celebrated at the party's local office. They released fish symbolizing the release of their leader. <sup>15</sup>
- In Shwebo Township, Sagaing Division, about 50 people attended celebrations. <sup>16</sup>
- In Allen Township, Magwe Division, NLD members made donations at a local monastery. 17

Meanwhile, scores of events were held around the world to celebrate Daw Aung San Suu Kyi's birthday. 18

# NLD and 88 Generation Students: endless persecution

- **6 June**: SPDC authorities in Mandalay closed down the garment shop of Ba Soe, the brother of Daw Win Mya Mya, a member of the Mandalay Division NLD Organizing Committee. <sup>19</sup>
- 11 June: an article in a state-run newspaper New Light of Myanmar threatened leaders of the 88 Generation Students group with "punitive punishment [...] more severe than legal action" if they continued their political activities.<sup>20</sup>
- 11 June: SPDC authorities, local police, members of the USDA and the paramilitary group Swan Arr Shin in Thar Yar Kone village, Maymyo Township, Mandalay Division, forced NLD youth Nay Myo Aung to resign from the party.<sup>21</sup>

In Rangoon, Thanlyin-Kyaikgaug pagoda management committee officials drove out more than 20 women NLD members who were praying for the release of Daw Aung San Suu Kyi. 22

In Zeegone Township, Pegu Division, a group of men fired slingshots at five women NLD members who had been praying for the release of Daw Aung San Suu Kyi at the Mya Thein Than pagoda. <sup>23</sup>

- **17 June**: SPDC authorities in Naung Kham village near Mandalay attempted to get information on NLD activities from Party member Ko Win Bo by threatening to close his shop.<sup>24</sup>
- **19 June**: Junta-backed thugs disrupted Daw Aung San Suu Kyi's 62<sup>nd</sup> birthday celebrations held at various locations across Burma:
  - o In Shwebo Township, Sagaing Division, USDA members threw stones at the Party's local office and placed sharp rivets to puncture tires on a road near the building.<sup>25</sup>
  - o In Allen Township, Magwe Division, USDA thugs pelted NLD members with sharp objects. <sup>26</sup>
  - In Rangoon, plain-clothed security police kept the NLD headquarters under surveillance and took photographs of Daw Suu's birthday celebration from across the road. A dozen trucks filled with USDA and Swan Arr Shin members were also stationed outside the NLD headquarters.<sup>27</sup>

15 June: An unidentified man reportedly linked to the local USDA assaulted Than Lwin, a 70-yearold member NLD elected MP in Mandalay. Than Lwin was returning home from a prayer vigil for the release of Daw Aung San Suu Kyi at the Alo Daw Pyait pagoda in Maddaya Township. 28 On 20 June, USDA members reportedly harassed him while he was undergoing surgery at a Mandalay hospital.<sup>29</sup>

# The resignations game: NLD vs. USDA

State-run newspaper New Light of Myanmar reported that 266 NLD members throughout Burma resigned from the Party in June. 30 The total number of resignations from the NLD now stands at 800 for 2007.<sup>31</sup> It is widely known that most resignations from the NLD are the result of threats and other forms of intimidation by regime officials. In some cases, the junta also offers economic incentives to entice NLD members to resign.

Uncoerced resignations, on the other hand, hit the junta-sponsored USDA, as members begin to realize the thuggish nature of the organization. In June, it was reported that for the first time in USDA's history at least 18 of its members in Mon State had resigned since April.<sup>32</sup>

# National Convention: the sham must go on

On 5 June, Lt Gen Thein Sein, SPDC acting Prime Minister and chairman of the National Convention Convening Committee, announced that the junta-sponsored constitution drafting body would reconvene on 18 July for its last session.<sup>33</sup>

- The NLD said it would continue to boycott the National Convention.<sup>34</sup>
- Ethnic armed opposition groups reiterated their opposition to the convention. On 6 June, the Karenni National Progressive Party, the Arakan National Council, as well as the umbrella group National Democratic Front<sup>35</sup>, rejected the legitimacy of the constitution-drafting process and refused to recognize its final outcome.<sup>36</sup> Hkun Htun Oo, imprisoned leader of the Shan Nationalities League for Democracy, also expressed its opposition to the National Convention.<sup>37</sup>
- The final session of the 15-year-old convention is expected to adopt guidelines covering the remaining seven chapters of the 15-chapter constitution.<sup>3</sup>
- The junta will seek approval of the draft constitution through a national referendum. A parliamentary election will be subsequently held and power will be handed over to a civilian government.39
- It is estimated the regime might have spent more than US\$3 million to fund the National Convention since its creation in 1993.<sup>40</sup>

## Militarization continues

The regime's military presence in Karen State intensified in recent months, with the SPDC Army setting up 33 new bases and building helicopter landing pads to facilitate the supply of weapons and ammunition to conflict areas. <sup>41</sup> Unlike previous offensives that ceased at the onset of the rainy season, the regime's military build-up in Eastern Burma continues. During the second week of June, two more SPDC Army battalions totaling nearly 300 soldiers moved from Chin and Arakan States to the frontline in Eastern Burma. <sup>42</sup> In Karen State, there are currently about 55 SPDC Army battalions. <sup>43</sup> The current offensive is causing 25,000 people to face starvation. <sup>44</sup>

# Military takeover

As part of its ongoing strategy to replace civilian positions with military personnel, in early June the SPDC's military security affairs department announced the transfer of nearly 2,000 army officers to state and divisional police departments. Earlier this year, the junta had transferred 3,300 military officers to civilian ministries.<sup>45</sup>

# ICRC, ILO, and UN thrash the SPDC

On 29 June, the International Committee of the Red Cross (ICRC) lashed out at the regime's continued abuses against civilians and detainees. The Geneva-based organization was forced to publicly criticize the SPDC because the junta ignored repeated pleas by the ICRC to discuss the ongoing abuses. <sup>46</sup> The ICRC drew particular attention to:

- the abuse of civilians affected by armed conflict along the Thai-Burma border, including the destruction of food supplies, violence, arbitrary arrest and displacement
- restrictions on the delivery of humanitarian aid and the movement of aid workers.
- the abuse of detainees forced to work for the SPDC army as porters, exposing them to armed conflict, exhaustion, malnutrition, degrading treatment and death;

An ILO Committee report presented to the International Labor Conference in June echoed the ICRC findings. The report said that forced labor is still widely used in Burma, especially by the army. Shortly after the ILO Committee issued its findings, on 21 June, U Kra Aung, a 40-year-old carpenter from the from Thaungtalann village, died while performing forced labor at an SPDC Army camp in Thaungtalann, Paletwa Township, Chin State. A total of 60 villagers were forced to provide labor for the renovation of barracks at the SPDC Army camp. 48

At the end of June, the UN Humanitarian Coordinator to Burma, Charles Petrie, delivered another body blow to the junta. Petrie was reported as saying that Burma's problems are the result of the SPDC's ill-informed and outdated socio-economic policies, lack of public expenditure, and uncompromising attitude towards the NLD, democracy and ethnic groups. Petrie also criticized the SPDC's restrictions of humanitarian agencies as being due to an "insufficient understanding of what the UN and NGOs are trying to do."

#### **Arrests and releases**

- **5 June**: SPDC police in Rangoon took 11 HIV patients into custody for participating in prayers at pagodas for the release of prominent HIV/AIDS activist and NLD member Phyu Phyu Thin. <sup>50</sup> The group was released on 8 June. <sup>51</sup>
- **6 June**: Police arrested three youths from Akyab, Arakan State, for displaying anti-Shwe Gas Project posters. <sup>52</sup>
- **7 June**: Police surveillance on prominent human rights activist and NLD member Su Su Nway at the Muslim Free Hospital in Rangoon was removed. She was told that she was no longer being detained. The 34-year-old activist was arrested on 15 May for campaigning for the release of Daw Aung San Suu Kyi. <sup>53</sup> [See *May 2007 Burma Bulletin*]
- **12 June**: SPDC intelligence agents in Kyauktaga Township, Pegu Division, detained labor rights activist Nyan Win.<sup>54</sup>
- 19 June: SPDC authorities in Taunggoat Township, Arakan State, arrested 25-year-old Maung Kyaw Naing for staging a protest on high inflation. His mother and his sister were also taken into custody later on the same day. 55
- **21 June**: SPDC police arrested Maung Maung and Maung Nyu, two residents of Mong Yu village in Muse Township, Shan State. They allegedly refused to comply with the SPDC authorities' relocation order. <sup>56</sup>
- **24 June**: SPDC authorities and fire brigade members in Rangoon arrested Ko Maung Oo for protesting against the junta's economic policies and calling for Daw Aung San Suu Kyi's release. <sup>57</sup>
- 27 June: SPDC authorities released 51 activists who were arrested and detained in May for participating in a prayer campaign for the release of Daw Aung San Suu Kyi. [See May 2007 Burma Bulletin]

## Drug cultivation: up or down?

- On 26 June, the UN Office on Drugs and Crime (UNODC) released its annual drug report which stated that Burma remained the world's second-largest opium producer and the largest producer of methamphetamines in Southeast Asia.<sup>59</sup>
- The UNODC report claimed that Burma's poppy cultivation fell 34% last year to 21,500 hectares.<sup>60</sup>
   Despite the reduction in area under cultivation, increased yields kept opium production in 2006 nearly the same as 2005.<sup>61</sup>
- However, a recent report issued by the Shan Herald Agency for News (SHAN) is highly critical of some of the conclusions drawn by the UNODC. The SHAN report stated that a random survey in late 2006 showed that several areas designated as "poppy-free" by the UNODC in their October 2006 report were actually still growing poppies under the direct patronage of the SPDC Army.

## **Karen State**

Repeated clashes between Karen National Liberation Army (KNLA), the SPDC Army and the SPDC-surrogate Democratic Karen Buddhist Army (DKBA) continued throughout the month. On 9 June, during a fire fight between KNLA and DKBA forces, a man and a three-year-old child were killed and several others were wounded when artillery shells hit Sit Hmudan Haung Asu Village near the Burma border town of Myawaddy. <sup>63</sup>

#### Karenni State

The Karenni National Progressive Party (KNPP) claimed responsibility for a 22 June attack on a bus traveling from Mawchi to the Karenni State Capital of Loikaw. Seventeen people were reportedly killed and eight others wounded in the attack. According to the KNPP, the dead were from the juntasponsored Karenni National People's Liberation Front (KNPLF) that had commandeered a civilian bus to transport troops, a common tactic to avoid attack.<sup>64</sup>

## **SPDC** targets Mon cultural groups

On 6 June, it was reported that the SPDC failed to renew operation permits for five local cultural organizations in southern Burma. A member of the Moulmein Mon Literature and Culture Sub-Committee (MLCC) said that the MLCC, the Kyaikmaraw's Mon Literature, the Culture Committee, and three other local organizations in the area were affected by the decision.<sup>65</sup>

# **DISPLACEMENT**

# World Refugee Day in Thailand: refugees go home!

On 20 June, Burmese activists around the world marked World Refugee Day. Meanwhile, refugees fleeing SPDC Army offensives continued to seek refuge in Thailand. Since April, at least 4,000 Karen villagers have fled fighting in Eastern Kyaukyi Township, Pegu Division and in Karen State.

- **5 June:** the bodies of three shot Karenni refugees were found near the Karenni Refugee Camp 1, in an area just inside the Burma border. <sup>68</sup>
- **6 June:** Thailand denied entry to 250 Karen, including many sick children and women, who were fleeing attacks by SPDC soldiers.<sup>69</sup> Days later, 36 refugees from Karenni State similarly fleeing SPDC military attacks were turned away from a refugee camp in Mae Hong Son.<sup>70</sup>
- **8 June:** 10 undocumented migrants from Burma were killed when their truck crashed while trying to escape Thai police.<sup>71</sup>
- **15 June:** Thai authorities arrested 10 IDPs in Karenni Refugee Camp I for entering the camp illegally.<sup>72</sup>

# Malaysian thugs crack down

On 25 June, thugs from the volunteer corps RELA arrested 217 asylum-seekers and UNHCR-recognized refugees from Burma in Kuala Lumpur. 73

# India-SPDC: the inconvenient marriage

India has to stay in the SPDC's good graces if it going to stay in the running for a share of Burma's oil and natural gas resources. But the issue of increased instability along the Indo-Burma border continues to be a serious impediment to good relations between the two countries.

On 4 June, a group of unidentified insurgents operating inside Burma opened fire on the India-Burma border town of Moreh. Heleven people from the Kuki and Meitei communities were killed in the attack. As a result of the incident, traffic and trading ground to a halt for 10 days along the Moreh section of the India-Burma border. Indian border security forces held the SPDC responsible for the incident.

In a continued effort to forge closer ties with the SPDC, on 25 June, media reports indicated India had started to train SPDC Air Force officers at the Indian naval base at Cochin. In addition, India was set to finalize the transfer of three BN-2 Islander maritime surveillance aircraft that was the subject of an agreement made in May. [See *May 2007 Burma Bulletin*] It was also reported that India decided to gift a Russian-made AL-72 helicopter to the SPDC and that four Indian helicopters made by Hindustan Aeronauticals Limited had already been given to the SPDC. <sup>79</sup>

# **ASEAN: Changing of the guard**

Surin Pitsuwan, former Thai Foreign Minister is set to replace current ASEAN Sec Gen Ong Keng Yong at the end of the year. On 20 June, Surin said that the new ASEAN charter could contribute to the democracy movement in Burma. In his prior role as Thailand's Foreign Minister, Surin was known for taking a hard line against Burma's military junta.<sup>80</sup>

## **EU** resolution condemns junta

In a resolution on Burma adopted by 73 votes to 1, Members of the European Parliament condemned the SPDC's oppression of the Burmese people and called for the release of political prisoners.<sup>81</sup>

## UN
